

TERMS OF REFERENCE (TOR)

FOR Provision of Relief support (A.2.)

1. Background

The "Association de la Jeunesse pour la Promotion des Droits de l'Homme et de Développement" (AJPRODHO-JIJUKIRWA) is a local Youth Organisation that works for the promotion of Human rights in Rwanda. The major role of the organization is to foster Human rights promotion and development, access to justice, governance, Economic empowerment, research, advocacy, and civil society strengthening.

In partnership with UN women, AJPRODHO is implementing the Project entitled "POST COVID-19 RELIEF SUPPORT FOR TEEN MOTHERS IN NYAGATARE AND GATSIBO DISTRICTS".

2. Objectives:

Programmatically, the aim of the intended intervention is Recovering better and inclusively from COVID-19 through Gender Sensitive Social Protection System in Rwanda. Specifically, the objective of the intervention is "to provide post COVID response through direct support to 840 teen mothers by giving them small domestic animals (Goats), tailoring machines and school materials to recover from post COVID-19 effects". **Provision of the above relief support package will be made of**:

- 90 Tailoring machines to 90 teen mothers.
- 250 goats to 250 teen mothers. The certified goat must be roosted or at the point of maturation.
- The scholastic materials to 500 teen mothers. These materials will include 1 dozen of notebooks, 5 Pens (Bic), 1 school bag, 2packets of hygienic pads, and 1bar of soap (1kg) for each of 500 students/teen mothers



3. Expected Results:

840 Teen mothers mostly affected by COVID-19 in Nyagatare and Gatsibo district increased access on socio-economic resources to reduce their vulnerability by providing them with:

- 90Tailoring machines
- 250 goats
- The scholastic materials for 500 teen mothers
