- 2. By submitting your EoI, your firm or agency accepts in full the conditions of this call, waiving any or own conditions of sale or transaction.
- 3. You have carefully read all instructions and conditions. You will ensure that all relevant information and documentation is provided in full and on time, noting that failure to do so may result in rejection of your submission.
- 4. Order of requested documents in proposal:
  - a. Submission letter duly signed, dated and stamped.
  - b. A brief description of a company or a company profile with full addresses "Its Legal Name, location area (Physical address), P.O. Box, Telephone number, E-mail, etc..." Also include your core area of business.
  - c. Range of goods/services offered under applicable category
  - d. Valid Tax clearance certificate,
  - e. References of related past work/ Experience justified by certificates of completion, executed contracts in similar domains in the last two years. (At least two references)
  - f. Certificate of Company Registration. RDB certificate of 3 years or above.
  - g. VAT registration certificate
  - h. Proof of use of EBM Machine
  - i. Valid RSSB certificate
  - j. Any applicable license depending on category where your firm/company has expressed interest e.g RURA certifications or license, Rwanda Standards Board certifications or license, ISO Quality certifications etc.

When analyzing the EOI, ALIGHT will take into account the following criteria:

 Review of requested documents/Administrative documents above to assess capability to supply goods or provide the services under the different categories.

#### A. SPECIFICATION OF ITEMS

All Suppliers/Contractors to Alight need to be registered with ALIGHT. If you haven't already registered with ALIGHT, please complete and submit an Application Submission Sheet enclosed in Section 9 below as well as the Vendor Registration Form in Section 10. These can be included in your EoI package.

#### 8. CONDITIONS OF THE TENDER

- 1. ALIGHT is in no way responsible for any costs associated with preparing the submission response.
- 2. ALIGHT reserves the right to alter the dates of the timetable.
- 3. Canvassing of ALIGHT staff in Alight or elsewhere in relation to this call will result in disqualification of that individual, agency or company.
- 4. ALIGHT will inform each respondent to the decision on their offer. ALIGHT is not obliged to justify or explain selection to any respondent.
- 5. ALIGHT does not do business with companies or individuals that may meet any of the following criteria:
- They are bankrupt or being wound up, are having their affairs administered by the courts, have entered into an
  arrangement with creditors, have suspended business activities, are the subject of proceedings concerning those
  matters, or are in any analogous situation arising from a similar procedure provided for in national legislation or
  regulations;
- They have been convicted of an offence concerning their professional conduct by a judgement that has the force of res judicata;
- They have been guilty of grave professional misconduct proven by any means that the contracting authority can
  justify;
- They have not fulfilled obligations relating to the payment of social security contributions or the payment of taxes
  in accordance with the legal provisions of the country in which they are established or with those of the country of
  the contracting authority or those of the country where the contract is to be performed;
- They have been the subject of a judgement that has the force of res judicator for fraud, corruption, involvement in a criminal organisation or any other illegal activity;
- Following another procurement procedure or grant award procedure, they have been declared to be in serious breach
  of contract for failure to comply with their contractual obligations.



If you submit an offer based on this request, it shall constitute a guarantee that neither your company nor any affiliate or a subsidiary controlled by your company or yourself is in breach of any of the above provisions.

In addition to the ineligibility criteria applied by ALIGHT, negotiation with potential vendors may be severed at any stage during a procurement process if it is found that they are subject to a conflict of interest or are guilty of misrepresentation in supplying the information required by ALIGHT as a condition of participation in the contract procedure, or fail to supply all of the information requested.
