Service provider for Coordination of pool of experts on agroforestry trainings

1. Client and background

Naturland – Verband für ökologischen Landbau e.V. ("Naturland") is a German-based international farmers' association that develops and disseminates organicfarming practices regionally, nationally and worldwide.

With a project financially supported by the German Federal Ministry for Economic Cooperation and Development (BMZ), Naturland aims to improve the livelihood of Rwandan coffee farmers and to create more and better jobs through organic agroforestry systems and capacity development.

Partnering with seven coffee cooperatives and companies, the project Job Partnership with Rwanda ("Better livelihoods for organic coffee growers and climate-risk mitigation through enhanced organic agroforestry systems and fair trade") runs until March 2025.

The project focuses on local capacity development and fair-trade facilitation. Through local capacity development, Naturland will support the seven coffee cooperatives and companies in their conversion towards organic agroforestry systems. To achieve this objective, 6 master trainers and 61 suitable trainers will need to be selected and assigned to the project so that they can conduct trainings on agroforestry-based organic coffee production with the various coffee farmer groups and this requires contracting of a service provider /consultancy who will be able to hire, lead and coordinate these two pools of experts (master trainers and trainers).

Naturland is, therefore, looking for an experienced service provider/consultancy firm in agriculture sector who can hire, assign, lead and coordinate the tasks of the two pools of experts for the project.

2. Description of the service sought

The following services and deliverables will be provided by the service provider to be commissioned:

- Select, conclude all administrative requirements and contract 2 pools of experts (the 1st pool for 6 master trainers and the 2nd one for 61 trainers). During the selection of the two pools, full CVs with relevant certificates from master trainers and short bios of 61 trainers should be presented to Naturland. Naturland reserves the right to accept or reject the proposed Master Trainers and Trainers based on objective qualification.
- Lead and coordinate the master trainers and trainers in delivering all the trainings to various farmer groups. The service provider is expected to ensure that the responsibilities of the master trainers and trainers are met as planned and timely. The task of the service provider will be mainly to do the coordination of the trainings to ensure the trainings take place within the planned time frame (including but not limited to logistics, catering etc.).
- The responsibilities of the 6 master trainers include:
 - o Train the 61 trainers on organic standards, including key aspects related to the new EU

organic regulation, Naturland standards and East African Organic Products Standards.

- Train the 61 trainers on the training methodologies to apply when delivering the training to farmers, including developing training manuals to be used by trainers when training farmer groups.
- Train the key staff of the 7 coffee partners on organic guarantee systems (i.e., internal control system, ICS, and participatory guarantee systems, PGS), supporting them towards compliance with the new EU regulation and Naturland requirements.
- Train lead farmers on how to operate the demonstration plots and which records to keep.
- The responsibilities of the 61 trainers include:
 - Conduct all the trainings to various farmer groups including 21 lead farmers on Naturland agroforestry-based organic coffee production, preparation for conversion to Naturland standards and preparation for inspection and first quality assurance visit.
 - Organize the farm visits necessary to check implementation progress of recommended practices per the conversion transition plans (action plans) developed as part of the mentorship/ coaching program.
- The contracts with the master trainers and trainers will be concluded by the service provider, and the service provider will assume full legal responsibility for their services and deliverables as described above as a **general contractor**. The service provider will be solely responsible for remunerating the master trainers and trainers and the remuneration to be quoted by the service provider under no. 4 below will include all remuneration, taxes and expenses relating to the master trainers.

The service provider will be required to obtain and arrange for, at its cost and risk, all supplies and materials required for the provision of the services and deliverables, including, without limitation, transportation, communication, and other related costs.

3. Performance period

The service provider will select, conclude all administrative requirements and contract the two pools of experts in June 2024 and carry out the rest of the activities listed under no. 2 until the end of December 2024. Naturland can provide a non-binding list of possible master trainers and trainers.

4. Scheduling for the Services

Trainers conduct all the trainings to various farmer groups (to be identified by Naturland) including 21 lead farmers on agroforestry-based organic coffee production, preparation for conversion to Naturland standards and preparation for inspection and first quality assurance visit. 5. Price structure

The remuneration includes all costs incurred by the service provider for its services (including all remuneration, taxes and expenses payable with respect to the master trainers and trainers). The service provider should clearly indicate in the offer the breakdown of the costs (Annex 3). Offers should be provided on net basis without VAT.

6. Exclusion criteria

- 1) Public contracts shall be awarded to competent, efficient (suitable) enterprises which are not excluded by analogous application of Sections 123 or 124 of the Act against Restraints of Competition (GWB). In the case of grounds for exclusion, section 125 of the Act against Restraints of Competition shall apply mutatis mutandis to self -cleaning and section 126 of the Act against Restraints of Competition shall apply mutatis mutandis to the maximum permissible duration of the exclusion. Section 123(1) no 4 and 5 of the Act against Restraints of Competition shall also apply insofar as the infringement is directed against public budgets. Section 124(1)(7) of the Act against Restraints of Competition shall apply mutatis mutandis with the proviso that the defective performance of the contract may not have led to the premature termination of the contract or to damages or a comparable legal consequence. In order to check any grounds for exclusion, the self-declaration (Annex 2) must be completed and duly executed.
- 2) Proof of entry in the commercial/professional register which confirms engagement and providing services in agriculture sector; not older than 12 months.
- 3) Completed information sheet being submitted (Annex- 1)

7. Evaluation criteria

The following core elements and competences are sought:

1) Proven experience in leading and coordinating pool of experts in the provision of trainings in the agriculture sector (max. 14 points)

- 3) Allocation of fee budget to Trainers and Master Trainers: It is very important to Naturland that the master trainers and trainers are compensated fairly for their time invested in their engagement. The offer with the highest allocation towards the fees of the trainers and master trainers receives 6 points, the offer with the lowest allocation receives 1 point. All others receive 3 points.
- 4) Price: The offer with the lowest total price receives 5 points, the offer with the highest price receives 1 point. All other offers receive 3 points.

The procedure will lead to the conclusion of a contract based on the "Terms of reference" (for sample see Annex 5 and Annex 6).
