Title : CONSULTANCY SERVICES FOR THE TRAINING OF "ABUNZI" IN RUHANGO DISTRICT ON CONFLICT RESOLUTION AND MEDIATION TECHNIQUES

1. **Haguruka** is a Rwandan non-governmental organization registered under Rwandan Law since 1991. The mission of the organization is to "protect and defend the rights of women and children through empowering them to reclaim their rights through access to justice across the country via Haguruka premises established in all provinces.

In line with government efforts to enforce the Alternative Dispute Resolution (ADR) approach designed to empower parties in conflict to resolve their disputes amicably, HAGURUKA is set to capacitate Abunzi in the Ruhango district by organizing training sessions to sharpen them with in-depth skills on conflict resolution in and mediation techniques, key laws, and gender equality related concepts. The overall objective is to maintain social cohesion between parties and mitigate the number of cases lodged in courts as well as cutting the price of court procedures.
