DETAILED REQUIREMENTS OF THE TENDER

I. EVALUATION CRITERIA

The Evaluation will be done in accordance to the administrative requirements, and technical qualification in the following stages

- a) Compliance with preliminary requirements, see administrative documents
- b) Compliance with technical specifications. A site visit may be conducted by the evaluation team to confirm technical capacity and compliance with the specifications before contract award
- c) Compliance with the supply requirements (schedule of unit prices) and shall be done Lot by Lot

d)

The lowest bidder (lot by lot for lots 1 and 2) with a technically responsive bid will be retained and awarded the contracts for this tender. Bidders may choose to bid on one or both lots and the contract may be awarded to one or two bidders

II. DOCUMENTS COMPRISING THE BID

The Bids shall comprise the following:

- 1) Bid submission form/Letter and Price schedules well printed and properly organized well signed, dated and stamped.
- 2) Copy of certificate of incorporation / Trading License issued by RDB
- Original or copy of the tax clearance certificate, valid on the date of submission issued by RRA
- 4) Detailed description of the items/parts to be supplied, supported by Catalogues establishing conformity to technical specifications.
- 5) Written confirmation authorizing the signatory of the Bid to commit the Bidder (power of attorney)

KEYNOTE TO BIDDERS

- a) The Estimated quantities in the table above are only indicative for evaluations purposes and shall not Constitute and be part of the contract.
- b) Bidders should note that the contract shall be for a period of six months, renewable once. Bidders are **advised** to hedge their prices to remain fixed through the period of the contract.
- c) No prices adjustment shall be *accepted* over the entire contract period of six months. Bidders are encouraged to hedge their prices to have a contract without price adjustments over the entire contract period.
- d) Bidders should also know that the evaluation shall be done on lot by lot basis and bidders with the lowest unit prices will be awarded those specific items.
- e) The inspection and tests of some materials will be conducted at Rwacof Export Ltd Premises. Only materials matching the required specifications and quality shall be considered for award.
- f) All the quoted Unit Prices should include all local taxes within Rwanda
- g) Delivery Period: Within 2 days from the date of contract signature / Purchase Order issuance. However partial delivery period is acceptable for some items already produced and which are available to be delivered immediately upon issuance of the purchase orders instead of waiting for two days.
- h) Post qualification of the bidders will be conducted by Rwacof Export Ltd. The results of due diligence shall lead to the award or elimination of the bidder(s).
- i) The details specifications for all items under this tender must be adhered to for compliance with requirements of this procurement process
- j) Selected supplier shall issue EBM invoices at the time of invoicing upon complete delivery of ordered parts
